# **PROCLAMATION...JUVENILE JUSTICE WEEK**

After a proclamation was read, a motion was made by Mr. Keith, seconded by Ms. Gorman and carried unanimously to proclaim October 6 - 12, 2024 as Juvenile Justice Week for the purpose to call on all Pennsylvanians, government agencies, public and private institutions, and schools to remain committed to raising awareness and understanding of juvenile justice.

# PROCLAMATION...DOMESTIC VIOLENCE AWARENESS WEEK

After a proclamation was read, a motion was made by Ms. Gorman, seconded by Ms. Keith and carried unanimously to hereby proclaim the month of October as Domestic Violence Awareness Month and urges all citizens to work towards the elimination of domestic violence in our community.

# **EQUIPMENT PURCHASE...SECURE TECHNOLOGY VALUE SOLUTIONS / JAIL**

At the request of Lesley Loveridge, Warden, a motion was made by Mr. Keith, seconded by Ms. Gorman and carried unanimously to approve the equipment purchase of a Body Scanner from Secure Technology Value Solutions in the amount of \$250,000.00 for the package.

#### <u>GAS PIPELINE EASEMENT – HOODLEBUG TRAIL, CENTER TOWNSHIP –</u> <u>PEOPLES NATURAL GAS COMPANY LLC / PLANNING</u>

At the request of Byron Stauffer, Office of Planning & Development, in consultation with the Indiana County Parks & Trails, a motion was made by Ms. Gorman, seconded by Mr. Keith and carried unanimously to approve a Gas Pipeline Easement with Peoples Natural Gas Company LLC, a Pennsylvania based utility company with offices in Pittsburgh, PA. Peoples Natural Gas Company LLC will be replacing a natural gas pipeline across the Hoodlebug Trail in Center Township, referred to as Parcel ID: 12-007-140. This gas pipeline replacement project is a result of a gas leak complaint to the PUC. The width of the Gas Pipeline Easement shall not exceed thirty feet (30'). Peoples Natural Gas Company LLC and its contractors would be required to restore the disturbed areas and use best efforts to ensure minimal disruption for the utilization of the Hoodlebug Trail. The Indiana County Parks & Trails has approved the location of the proposed gas pipeline. The authorization also allows for Commissioner Mike Keith, Chairman, to sign the Gas Pipeline Easement on behalf of Indiana County.

#### <u>REIMBURSEMENT AGREEMENT – PENNDOT – APPALACHIAN REGIONAL</u> <u>COMMISSION (ARC) ACCESS ROAD PROGRAM - 119 BUSINESS PARK ACCESS</u> <u>ROAD PROJECT – PHASE II – CENTER TOWNSHIP / PLANNING</u>

At the request of Byron Stauffer, Office of Planning & Development, on behalf of the Indiana County Development Corporation, a motion was made by Ms. Gorman, seconded by Mr. Keith and carried unanimously authorize the signing of a General Reimbursement Agreement for Federal-Aid Highway Projects, specifically through the Appalachian Regional Commission (ARC) Access Road Program in the amount of \$500,000.00. Authorization also allows for Commissioner Mike Keith, Chairman, to sign the General Reimbursement Agreement on behalf of Indiana County.

The 119 Business Park Access Road Project scope will provide access to approximately 10-acres of previously undeveloped business park property for light manufacturing and industrial development. The proposed project will result in a new 540 LF (0.102 mile) access road that is 24' wide with 2' curb gutter and 100' diameter cul-de-sac, including all development phases, such as engineering, design, survey, administration, inspection & testing, environmental, permitting, grading, stormwater management, lighting, markings and signage, according to applicable design standards. The new roadway will be dedicated as a public road to Center Township following close-out of the project.

The total estimated project budget is \$1,079,195.00, which has been approved by PennDOT D-10. The balance of the funding will be a \$367,500.00 State grant through the Commonwealth Financing Authority Multimodal Transportation Fund (CFA MTF) and \$211,700.00 through the Indiana County Liquid Fuels Tax Funds.

Request authorization for Commissioner Mike Keith, Chairman, to sign the General Reimbursement Agreement on behalf of Indiana County.

#### GRANT APPLICATION...JAG LOCAL SOLICITATION GRANT FROM THE DEPARTMENT OF JUSTICE / PROBATION & SHERIFF
